

PRIVACY POLICY

Australian Oztag is committed to protecting the privacy and personal information of our participants, members, customers, and website visitors. This Privacy Policy outlines how we collect, use, disclose, and protect personal information in accordance with applicable privacy laws and regulations.

COLLECTION OF PERSONAL INFORMATION

- We may collect personal information directly from individuals when they register for events, programs, or memberships, make inquiries, or interact with us in any other way.
- Personal information collected may include names, contact details, date of birth, gender, payment information, and any other information necessary for the provision of our services.

USE OF PERSONAL INFORMATION

- We use personal information for the purposes of providing and improving our services, communicating with individuals, processing payments, and responding to inquiries.
- Personal information may also be used for marketing and promotional purposes, with the option to opt-out of receiving marketing communications at any time.
- We only collect and use personal information where we have a legal basis to do so, such as when it is necessary for the performance of a contract, compliance with legal obligations, or with consent where required.

DISCLOSURE OF PERSONAL INFORMATION

- We may disclose personal information to third-party service providers who assist us in providing and managing our services, such as payment processors, event organisers, and marketing agencies.
- These service providers are contractually obligated to protect the confidentiality and security of personal information and are only permitted to use it for the purposes of providing services to us.

DATA SECURITY

- We implement appropriate technical and organisational security measures to protect personal information against unauthorised access, disclosure, alteration, or destruction.
- These measures include encryption, access controls, and regular security assessments.
- We retain personal information for as long as necessary to fulfill the purposes for which it was collected unless a longer retention period is required or permitted by law.

INDIVIDUAL RIGHTS

- Individuals have the right to access and correct their personal information held by us, subject to certain exceptions and limitations under applicable law.
- Individuals have the right to opt-out of receiving marketing communications from us at any time by following the instructions provided in the communications or contacting us directly.

PHOTOGRAPHY

- Anyone taking photographs or recording at any Oztag event must have a valid reason for doing so.
- All concerns regarding inappropriate or intrusive photography should be reported in confidence to the player's coach, venue managers, tournament director, or Australian Oztag.
- Any person who objects to having their photograph or footage of them taken should notify the coach or Australian Oztag otherwise it is presumed that photographs may be taken and used by Australian Oztag in any Oztag related publications or press releases.

JUNIOR POLICY

- Any adult seeking to take photographs of any player must first speak with the coach of that team ideally or as an alternative, the venue managers or tournament director. This is a fundamental requirement, not just a courtesy.
- If any of the players' parents or carers object, then no photographs may be taken.



MEDIA RELEASE

• If at any time a photograph or video footage (image and voice recordings) of any player/s (seniors or juniors) is used for promotional events for Australian Oztag or individual venues within Australian Oztag, then authorisation must be completed by the player. If the player is a child (under the age of 18), then authorisation must be completed by the players parent / guardian.
